

## **OFFICIAL TERMS & CONDITIONS**

CIEE Study Abroad is offering a grant toward 2022 spring study abroad, valued at up to \$9,750 for 3 blocks, or \$6,500 for 2 blocks for eligible spring 2022 CIEE study abroad programs. The following conditions apply:

### **1. STUDENTS MUST ATTEND ANY CIEE SPRING 2022 OPEN CAMPUS PROGRAM IN:**

- Copenhagen
- London
- Rome

### **2. STUDENTS MUST OPT-IN**

Students must opt-in to receive the grant by completing the form on this landing page:

<https://www.ciee.org/go-abroad/college-study-abroad/global-cities-grant-lp>. Students who have already applied or have been accepted into eligible program(s) may opt-in to claim the grant. Any student who studies abroad on any of the aforementioned cities but does not complete the form may not be eligible for the scholarship.

### **3. STUDENTS MUST APPLY AND BE ACCEPTED TO A CIEE SPRING 2022 STUDY ABROAD PROGRAM**

Students must apply and submit their program application by the corresponding application deadline date for that program at <https://my.ciee.org/login>. Acceptance to the program by CIEE and associated host institution, if applicable, is required. Any student who chooses to apply to an Open Campus Block Program must attend a minimum of two (2) blocks at eligible sites to be eligible to receive the grant. Note the value of

the scholarship is valued at \$3,000 per block (total value two [2] blocks \$6,000; three [3] blocks \$9,000).

#### **4. STUDENTS MUST CONFIRM THEIR PARTICIPATION AND PAY ANY REQUIRED DEPOSIT**

If a student is accepted to the program for which they have applied, they must confirm participation/enrollment formally through CIEE's application system and pay the required deposit. Any unused portions of the grant will be forfeited, is not be redeemable for cash, and may not reduce the value awarded for tax purposes. All federal, state, local and other taxes, costs, and expenses regarding the use and acceptance of the scholarship are the sole responsibility of the recipient.

#### **5. SCHOLARSHIPS**

Claiming the "grant" will count toward scholarship "caps" or maximums. No other CIEE scholarships or grants may be applied to these programs.

#### **6. RELEASE AND LIMITATION OF LIABILITY**

By participating in the promotion, individuals who opt-in agree to release and hold harmless CIEE, Inc., any administrator, their employees, legal representatives, successors and assigns, and any advertising and promotional agencies (collectively, the "Released Parties") from and against any claim or causes of action, suits, debts, indirect or direct damages arising out of participation in the promotion, or the awarding, acceptance and use or misuse of a scholarship.
