

Terms & Conditions

CIEE TEFL REFER A FRIEND PROGRAM

NO PURCHASE IS NECESSARY TO ENTER. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. ELIGIBILITY CIEE TEFL Refer a Friend program is open to everyone. This program only applies to the CIEE 150-hour TEFL Certification course and CIEE Destination TEFL programs. There is no limit to the number of CIEE TEFL Refer a Friend program bonuses an individual can receive.

3. Released Parties assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. Released Parties are not responsible for any problems or technical malfunction of any telephone network or telephone lines, computer on-line systems, servers, or providers, computer equipment, software, failure of any e-mail or entry to be received by Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any Website, or any combination thereof, including any injury or damage to participant's or any other person's computer relating to or resulting from participation in this program or downloading any materials in this program.
