OFFICIAL RULES GENERAL TERMS AND CONDITIONS

- The giveaway is open only to U.S. legal residents who meet ALL of the following criteria:

Entry will open at 9:00 AM Eastern Time ("ET") on November 27, 2024 and close at 11:59 PM ET December 6, 2024, the "Entry Period"). Entries

submitted before or after the Giveaway Entry period will be disqualified. Proof of submission will not be deemed to be proof of receipt. All entries and requests become the property of Sponsor and will not be acknowledged or returned.

2. THE SPONSOR

A FREE LUGGAGE SET WILL NOT BE AWARDED IF THE GRAND PRIZE WINNER DOES NOT DOWNLOAD THE CIEE MOBILE APP AND START A CIEE STUDY ABROAD APPLICATION.

Five (5) grand prize winners will be chosen, and will receive (i) one (1) Away Checked Bag: "The Large Flex" (ii) one (1) Away Carry-On Bag: "The Carry-On" (iii) one (1) CIEE Study Abroad Backpack, and (iv) CIEE Study Abroad Luggage Stickers (Total Approximate Retail Value ("ARV") of Grand Prize: ~ \$750).

If a Grand Prize winner is selected and is unable to participate in the corresponding CIEE program, the selected Grand Prize winner will forfeit the luggage set, and another winner may be selected from among eligible entries received.
